

MID SUSSEX DISTRICT COUNCIL

TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER 1977

WHEREAS the MID SUSSEX DISTRICT COUNCIL of Oaklands Oaklands Road Haywards Heath in the County of West Sussex being the appropriate Local Planning Authority within the meaning of Article 4 of the Town and Country Planning General Development Order 1977 is satisfied that it is expedient that development of the descriptions set out in the Schedule hereto should not be carried out on land at Hanbury Park Haywards Heath West Sussex being the land shown edged red on the plan annexed hereto unless permission therefor is granted on application made in that behalf under the Town and Country Planning General Development Order 1977

AND WHEREAS the Council is further of the opinion that development of the said descriptions would constitute a threat to the amenities of its area and that the provisions of paragraph 3(b) of the said Article 4 should apply to this Direction

NOW THEREFORE the said Council in pursuance of the powers conferred upon it by the said Article 4 hereby direct that the permission granted by Article 3 of the Town and Country Planning General Development Order 1977 shall not apply to development on the said land of the descriptions set out in the Schedule hereto

THIS DIRECTION is made in pursuance of the provisions of paragraph (3)(b) of the said Article 4 and shall remain in force until Fourth day of January 1986 (being six months from the date of this Direction) and will then expire


unless it has been approved by the Secretary of State for the Environment before that date

This Direction may be cited as the "MID SUSSEX DISTRICT (HANBURY PARK, HAYWARDS HEATH) DIRECTION 1985"

SCHEDULE

The use of land (other than a building or the curtilage of the building) for any purpose or purposes except as a caravan site on not more than 28 days in total in any calendar year (of which not more than 14 days in total may be devoted to use for the purpose of motorcar or motorcycle racing or for the purpose of the holding of markets), and the erection or placing of moveable structures on the land for the purposes of that use being development comprised within Class IV 2 referred to in Schedule 1 to the said Order and not being development comprised within any other Class

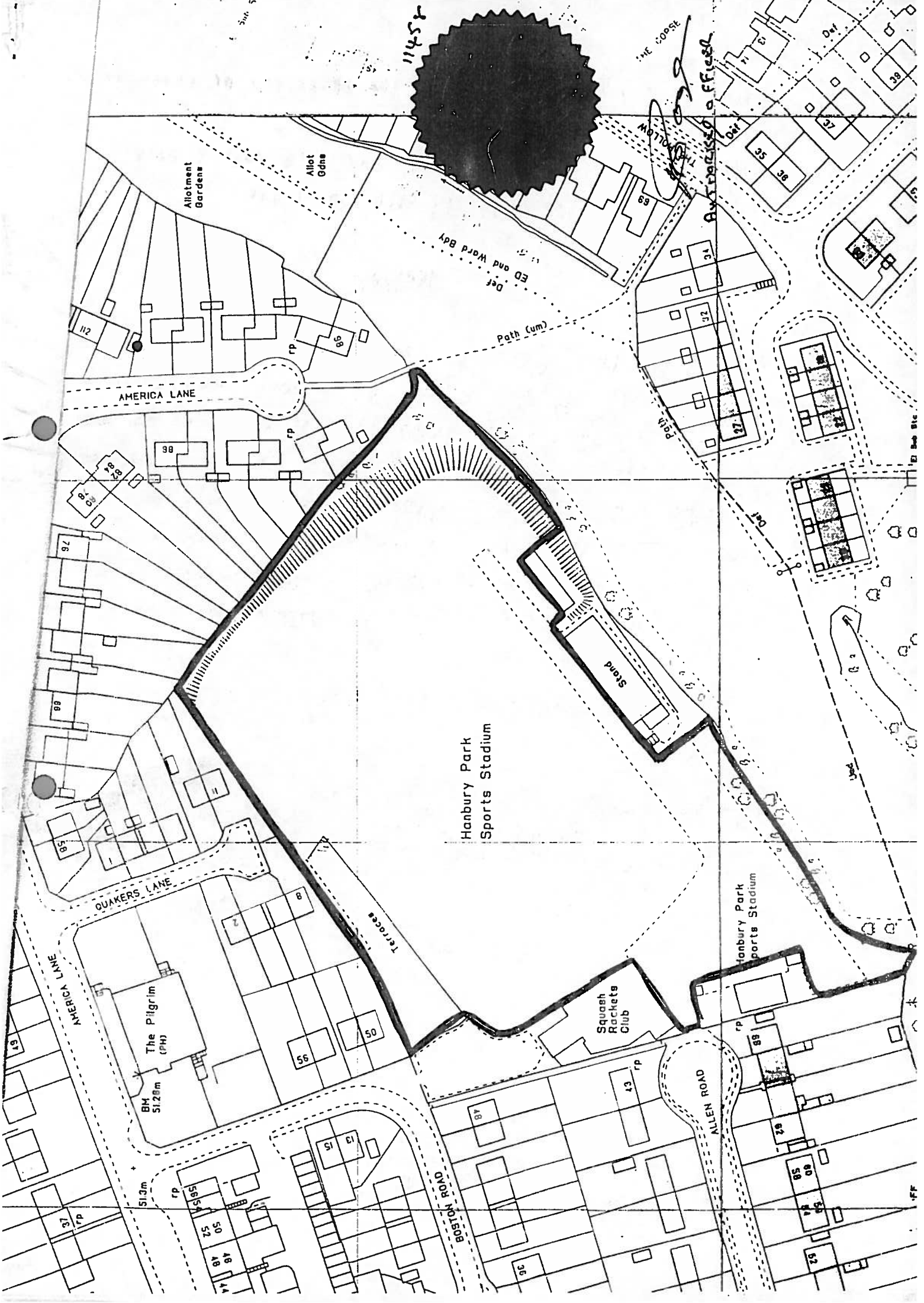
