

## **Public Consultation on The Heath Conservation Area Appraisal**

In March 2007, the Council held an exhibition and Public Meeting to illustrate the work that had been carried out on The Heath Conservation Area Appraisal. The exhibition was held at Clair Hall, Haywards Heath from 15<sup>th</sup> to 30<sup>th</sup> March 2007. The public meeting was also held at Clair Hall on the evening of the 16<sup>th</sup> March and was very well attended.

The exhibition set out a detailed assessment of the different character areas of the conservation area, suggested a number of changes to the boundary and provided a list of ideas for enhancement. A questionnaire was made available at these events, seeking the views of the public on the proposals. The deadline for the receipt of comments was Friday 20<sup>th</sup> April 2007.

This document summarises the questionnaire comments received and sets out the Council response to these. Where possible suggestions made by the public have been included in the appraisal document.



**Summary of Comments to Conservation Area Appraisal Questionnaire**

**Question 1 Do you agree with boundary changes?**

Mrs S Murray	No's 26 and 28 Sydney Road should be retained in the conservation area. These are 1920's houses with character and they could be redeveloped if taken out.	Agree. Following consultation with residents and relevant organisations it is not intended to remove these properties from the conservation area, as they are 1920's properties of similar scale and form to the others on the south side of Sydney Road, set in mature attractive gardens and are not obtrusive in the street scene. If they are removed from the conservation area there could be pressure to redevelop these properties to the detriment of the conservation area. The boundary will not be amended to exclude 26 and 28 Sydney Road.
Mr C Manton	The north side of Sydney road should be included. There are some fine buildings, 23 and 25 are 1870's, large bay windows, decorative brickwork, 19 and 21 built around 1840's with fine balconies and bargeboards. St Richards Church should also be included.	Agree. It is proposed that the conservation area should be extended to include St Richards Church, which is Grade II listed, and nos 19, 21 and 23 Sydney Road. These houses are some of the oldest on Sydney Road and indeed in Haywards Heath. They appear on the 1879 R. E. Ordnance Survey Map of the town engraved by E May.
Mrs L Walker	Retain existing boundary and also include the area at the rear of Oathall Road called Greenways.	Following consultation with residents and relevant organisations it is not intended to remove any areas from the conservation area. Regarding including the area called Greenways, it is considered that this area is not of the same general character as The Heath Conservation Area and would not be suitable for inclusion in this conservation area. However it is recognised that the protection of the setting of the conservation area is very important and this will be reflected in the appraisal document. In the section in the appraisal document on Ideas for Enhancement, it will clearly say that when considering proposals for development adjoining the conservation area consideration must be given to the effect of the

Mr O Lund	The conservation area should be kept as intact as possible as changes could set a precedent for changes in the future to enable development.	Agree. Following consultation with residents and relevant organisations it is not intended to remove any areas from the conservation area.
Mr B Phelan	Greenways should be included and the setting of the conservation area considered as this can affect the character.	It is considered that the area to the rear of Oathall Road, adjoining the conservation area, called Greenways is not of similar character to The Heath Conservation Area and would not be suitable for inclusion in this conservation area. However it is recognised that the protection of the setting of the conservation area is a very important consideration and this will be reflected in the appraisal document. In the section in the appraisal document on Ideas for Enhancement, it will clearly say that when considering proposals for development adjoining the conservation area, consideration must be given to the effect of the proposals on the setting of the conservation area and on character and appearance of the conservation area itself.
Mr B Girvan	Agree with the proposed inclusion of the magnificent Turner House in Sydney Road. The semis in Sydney Road and the flats on the corner of Oathall and Heath Roads should not be removed. The flats have important space about them with specimen trees.	Agree. Following consultation with residents and relevant organisations it is not intended to remove any areas from the conservation area. It is proposed that the Turner property (no 16 Sydney Road) will be included in the conservation area.
Miss B Wood	The north side of Sydney Road should be included. Disagree with the removal of properties in Sydney Road and the corner of Oathall and Heath Roads as this could lead to unwelcome piecemeal development.	The general character of the north side of Sydney Road was not considered to be of the same character as the south side of Sydney Road, when the conservation area was designated in 1989. It originally contained some warehouse buildings and bungalows some of which have now been redeveloped recently. It is recognised that the western end does contain some older character properties including St Richards Church and it is proposed to include these properties within the conservation area. Mrs P Hendey	The area will be more easily managed with rounded boundaries. I agree with the additions.	Noted.

Mr S Trott	Consideration should be given to linking Oathall Road with Lindfield Common/ High Street via West Common to create a narrow strip or corridor conservation area that links the two main areas. Also consider including St Paul's on the Green or at least the Lodge House.	Lindfield Common and Lindfield High Street are included in the Lindfield Conservation Area. It would not be appropriate to link these areas to The Heath Conservation Areas, as they are very different in character. It is not good practice to designate large swathes of the built environment as conservation areas as this would weaken the conservation area designation as a whole. West Common is different character to The Heath Conservation Area and is not considered suitable for inclusion in this conservation area. The Lodge House on Oathall Road is already included in the conservation area.

**Question 2 what are the special features of the Conservation Area that contribute to its character and appearance?**

Mr C Manton	Local building traditions, high quality brickwork and many examples of superior building design lacking in modern equivalents. Distinctive trees and hedges give the area considerable character. No 16 Sydney Road has traditional tiling to front elevation.	Noted. These comments support the conclusions that will be drawn in the appraisal.
Mrs L Walker	Victorian buildings, large gardens, trees.	Agree. These features will be identified in the appraisal.
Mr O Lund	High precedence of families in an otherwise commercial part of the town, parks, playgrounds, greenery etc.	Noted. The appraisal document will include a statement about the occupation of many of the properties by families which contributes to the character of the area. The park, playground and greenery will be identified in the document as important features.
Mr B Phelan	Secluded rear gardens except these are being destroyed e.g. 60 Oathall Road. The setting is also important and development should be controlled adjoining the conservation area.	Noted. The development pressure on the large gardens will be recognised in the appraisal document in the section on Problems and Opportunities, and that this threatens to undermine the character of the

		conservation area.

The appraisal document will identify important details and features in the conservation area and on individual buildings. The establishment of a heritage trail for this area and for Haywards Heath as a whole would be worthy aim. It is agreed that the identification of important buildings in the appraisal document could form the basis for a Local List of buildings of architectural and historic interest. The section of the appraisal document on Ideas for Enhancement will seek to resist the removal of historic features, important details and the loss of front gardens and the document recognises that the appearance of parts the conservation area should be improved.
Mrs L Walker	Flats being built, development of back gardens, creeping development that is changing the area is causing harm to the conservation area.	The section of the appraisal document on Problems and Opportunities identifies threats to the conservation area

There is a need to retain a mix of dwelling types to provide sustainable communities.	Noted. See comments above on these issues. Mrs P Hendey	The traffic in Oathall Road is causing harm. The speed limit of 30mph should be rigorously enforced. The redevelopment of large gardens should be prevented.	Noted. In the section of the document on Ideas for Enhancement traffic management proposals will be suggested.
Mr Simon Trott	There is poor/low quality street furniture such as benches and street lamps that are not heritage style, the children's play equipment in the park is old, and litter collection is infrequent. There is a need for more visible/ frequent policing as there is vandalism to fences and general graffiti damage.	Noted. In the section of the document on Ideas for Enhancement it is proposed that the quality of the street lighting and street furniture should be improved. The issue of litter collection and the problem of vandalism

		will be mentioned to the Council's Estate Management section to seek ways to address these problems through improvements in litter collection and more visible surveillance or policing and partnership working.
Mrs C Hewitt	Buildings can be in poor repair, lawns not mown, hedges untrimmed, windows not painted and front gardens used for storing old cars makes the area unsightly. The new development on the north side of Sydney Road is causing harm.	The appraisal document will recognise that parts of Sydney Road have an unkempt appearance and it will seek to address this in the section on Ideas for Enhancement. The importance of the setting of the conservation area will also be recognised in this section.
Mr R Hendey	Traffic through Oathall Road has reached major levels with large lorries passing through. Lorries over 10 tons should be banned and the 30mph speed limit enforced. Road surfaces should be upgraded to European standards for residential roads in tons to reduce noise levels. More frequent road clearing and verge tidying would be welcome too.	Noted. In the section of the document on Ideas for Enhancement, traffic management proposals will be suggested.
Dr D Jenkins	The exhibition should be the beginning of clear guidance about conservation areas. What is needed is a passion about conservation areas and their buildings including flora and fauna. At present these areas are under extreme pressure from developers.	Agree. It is hoped that the appraisal will provide clear guidance on what is special about this conservation area and how it can be preserved and enhanced. The document will recognise that this conservation area is experiencing severe pressure for development and will seek to identify ways to allow limited development that would not harm the character of the area.
Mrs I D Dolder	The long straight Oathall Road with overhanging trees is beautiful. Harm can be prevented by not allowing any more houses to be demolished. Sheds and portable garages however temporary do not enhance the conservation area when positioned in front gardens.	Agree. The appraisal document will state that incompatible garden sheds and garages especially in front gardens should be resisted.
Mrs M Tilbury	Recently a house and garden was redeveloped for flats in the conservation area. There is concern that new development on the site of Clair Hall which would ruin the surrounding area.	Noted. The appraisal document will identify that the Town Centre Masterplan proposes the redevelopment of Clair Hall on the western edge of the conservation area. However the document will also state that any new building should be of a high standard of design with an active edge with Clair Park to overlook the park to reduce crime and vandalism.
Mr I Hewitt	Demolishing houses in the conservation area to build flats is causing harm to the conservation area.	Noted. The appraisal document in the section on Problems and Opportunities will identify threats to the conservation area which could undermine its character and will propose a number of ways that these might be addressed.
Mr D Saunders	Pressure to develop mature gardens is causing harm. Development which is allowed should provide a balanced range of dwellings and should be in sympathy with the area.	The appraisal document in the section on Problems and Opportunities will identify threats to the conservation area which could undermine its character and will propose a number of ways that these might be

		addressed. It will also be recognised that there a large number of family dwellings in the conservation area and that it is important to provide a range of dwellings for a balanced mixed community.
Mr A Burstow	The traffic on Oathall Road is too fast, pavements are too narrow. Oathall Road would benefit from sensible speed limits, but not speed humps.	Noted. In the section of the document on Ideas for Enhancement traffic management proposals will be suggested.
R Walker	Houses 11-17 Oathall Road are continually being extended/ modified or threatened. If this is allowed it would dramatically alter this part of Oathall Road. At the rear of nos 28A & B and 30 Oathall Road there still exists the original garden walls dividing the gardens and believed to be 110 years old. These are an unique feature in Haywards Heath and vital to the character of the conservation area.	Agree. These beautiful Victorian villas are key features with very attractive detailing and give this part of the conservation area its distinctive character. The original garden wall will be mentioned in the appraisal document as an important feature and it is noted that there are other old walls that are still in place that back on to the recreation ground e.g. the walling that exists along the rear of the properties in Heath Road.
Miss E Sims	The hedges backing onto the Heath should be maintained and enhanced. If the Clair Hall site is redeveloped any future building should not be too high and bulky in appearance nor impose on the general view from the recreation ground.	Agree. This hedging contributes to the character of this part of the conservation area. The document in relation to Clair Hall will state that any new building should be of a high standard of design with an active edge with Clair Park to overlook the park to reduce crime and vandalism.

Mr C Manton	If a semi-detached house is thoughtlessly altered it detracts from the adjoining semi even if that property is well preserved.	Noted. The appraisal document will seek to prevent unsympathetic alterations in the conservation area.
Mr S Trott	Agree with the enhancements provided it results in positive proactive action.	Noted.
Mrs C Hewitt	Encouragement through incentives should be given to foster a shared responsibility for the maintenance of the appearance of the area.	Agree. An important outcome of this appraisal document will be to encourage both residents and the District Council to take action to improve the appearance of the area and to recognise what features need to be preserved and enhanced to protect its character.
Dr D Jenkins	It is important to develop this. It gives respect and passion for conservation areas and identifies the gems that exist in the town.	Agree. Mr C Manton	Signage could be provided to identify the fragment of the original heath or information on the role of Sydney Road as the rural link between the station and Lindfield in the 1840's.	Noted. The establishment of a heritage trail and relevant signage for this area and for Haywards Heath as a whole could be developed in collaboration with the Town Council, the Museum Trust and the Haywards Heath Society.
Mrs L Walker	More trees should be planted.	Noted.
Mr O Lund	The addition of a heritage trail.	Noted. The establishment of a heritage trail and relevant signage for this area and for Haywards Heath as a whole would be worthy aim. This could be developed in collaboration with the Town Council, the Museum Trust and the Haywards Heath Society.
Mr B Girvan	Providing advice on Harold Turner houses from local sources, keeping a list of Turner plans, typical details of the properties and suppliers of quality materials.	An exhibition on Harold Turner's work prepared by the Council took place a few years ago. A leaflet was prepared to accompany this which identifies ways to preserve and enhance Turner properties.
Mrs P Hendey	The front gardens of the block of flats on the corner of Oathall and Heath Roads would be less stark if trees and shrubs were planted around it.	Noted. It is considered that the open aspect of this site allows views down Oathall Road and along Heath Road and highlights the specimen trees on the Oathall Road frontage. It is agreed that some planting close to Arbour Court would screen the building.
Mr S Trott	Differentiate between the conservation area and the rest of the town by providing high quality street furniture and pavements. The park should be made accessible for all in the community. The cricket pavilion could be used as a cafe when not in use for cricket matches or events as is the case at Southover, Lewes.	Noted. The area could be enhanced by providing better quality street furniture. The suggestion of the use of the cricket pavilion as a café or for events will be suggested to the cricket club and the Council's Leisure Department and would encourage greater use of this park area.
Mrs C Hewitt	Re routing overhead utility cables, traffic calming, more litter bins, nature trail and identification of species and community events such as blackberry picking sessions.	Agree. The existence of unsightly cables will be recognised in the appraisal. The need for more litter bins and more regular litter collections will also be identified in the document. The section of the Council responsible for street cleaning will be notified of this. The idea of a nature trail and community events could be linked with the suggestion in the appraisal document that the wooded heath area of the recreation ground should be enhanced by the preparation of a management plan to encourage wildlife and public access. A local conservation group could be established as has been done elsewhere in Mid Sussex.

Mr R Hende	Improve road surfaces, enforce speed limit, and ban lorry traffic. Give more attention to the maintenance of Clair Park. The permanent practice nets should be near the pavilion.	Noted. In the section of the document on Ideas for Enhancement traffic management proposals will be suggested. However planning permission has been granted for the cricket practice nets at the northern end of the cricket field as there was nowhere suitable near the pavilion.
Dr D Jenkins	Can anything be done about the extensive white finish on 61 Oathall Road which makes it not in keeping with the rest of the houses?	This white finish will be mentioned in the appraisal document as not in keeping with the adjoining semi detached house which may encourage the owner to remove it.

It will be suggested in the appraisal document that the wooded heath area of the recreation ground should be enhanced by the preparation of a management plan to encourage wildlife and public access. A local conservation group could be established as has been done elsewhere in Mid Sussex.
