



Mid Sussex District Council Local Development Framework Small Scale Housing Allocations Development Plan Document Adoption Statement

April 2008

This statement has been prepared in accordance with Regulation 24(4) and Regulation 36 of the Town and Country Planning (Local Development) (England) Regulations 2004 and gives notice that the Small Scale Housing Allocations Development Plan Document was adopted by Mid Sussex District Council on 16th April 2008.

The adopted document comprises the Submission Development Plan Document, amended in accordance with the Inspector's binding report of his examination of the document, received by the Council in November 2007.

The Small Scale Housing Allocations Development Plan Document identifies a number of non-strategic scale housing sites that will help to meet the District's housing land requirement for the period up to 2016. It now forms part of the Local Development Framework for Mid Sussex.

Any such application must be made by not later than 19th June 2008, which is the end of the period of six weeks starting on the date of advertisement (8th May 2008).
