#### Explanation of how the cooperation has influenced plan making

Discussions between MSDC officers and NHS Sussex on planned and proposed housing growth within the emerging District Plan resulted in an early indication from NHS Sussex that the level and location of growth would unlikely trigger the requirement for a new practice in the district, but this would be reviewed as the Plan progressed. The Infrastructure Delivery Plan was prepared on this basis.

The policy wording for the significant site allocations reflects that discussions on future provision were subject to further consideration by NHS Sussex.

#### Explanation of how the cooperation has influenced plan making

The policy wording for the significant site allocations refined to reflect that discussions on future provision were subject to further consideration by NHS Sussex.

Feedback from the NHS Sussex Integrated Care Board through the Infrastructure Delivery Plan (IDP) engagement exercise with NHS Sussex and other infrastructure providers led to the inclusion of an updated position statement within the IDP (Regulation 19 stage). The position statements provide a summary of the key issues, current provision within the district and source of funding. The IDP Schedule for Health was updated to provide updated Potential Funds.

Outcomes of discussions were fed into Policy DPI2: Planning Obligations and the development of Appendix 5: Developer Contributions, which in turn informed the inputs to the viability study enabling the development of scenarios to be tested to ensure deliverability of the Plan.
